# Denair Municipal Advisory Council Meeting Minutes Zoom Meeting July 6, 2021, 7:00 PM

A. James Brugger called meeting to order at 7:01 PM and led the pledge to the flag.

## II. Introduction and Roll Call

A. Members present: James Brugger, Adam Dalton, Billy Myers, Mary Ann Riner (absent), and Kimberly Stokes (absent)

## III. Public Comments

- A. Community member Does the County have a requirement for community parks to be included with new developments? New subdivisions without park spaces creates a quality of life issue and County should make developers put them in.
- **B.** Erica Inacio (Chief Executive Office) Question for Planning Department: Does Planning push on developers to build park spaces? Answer from Jeremy Ballard with Planning: There are community plans and County policy for developing parks. The threshold is if the development is greater than fifty lots.

# A. Public Safety:

- i. California Highway Patrol (<u>https://www.chp.ca.gov/home</u>) Officer Moore
  - a. No statistics for June were available at the time of the meeting.
  - b. The Academy reopened and the next transfers will be in September.
  - c. They will be hosting two street racer training and coordination days. They will be focusing on street racing prevention in the area.
  - d. Citizens should be proactive and report traffic complaints via phone (209-545-7440)
- ii. Stanislaus County Sheriff (<u>https://www.scsdonline.com/</u>) Deputy Davis (Community Resource)
  - a. There were 84 calls in June, which is lower than the past years. Most were property crimes, theft, and vandalism.
  - b. It is a busy time of the year and they are trying to get out to the community more.
  - c. Use the GO REQUEST app to report suspicious activities.

# iii. Denair Fire Department - See attached report

- a. The DFD has new staffing. Two will be on staff at night; they currently have 23 active fire fighters.
- b. DFD Deep Pit BBQ will be on September 11. Tickets will be coming soon.

### VIII. Action Items:

### A. Recommendation for <u>PLN2021-0009</u> – WPD Homes, Inc.:

- i. The project is scheduled to go to Planning soon. They need a recommendation from the MAC tonight.
- **ii.** Pat Davis with WPD Homes and Civil Engineer, Rod Hawkins, were available to answer questions.
- iii. The project is a rezone from R-A to P-D and medium density residential (R-2).
  - a. Four trees will be removed
  - b. Street improvements will be required
  - c. Swales will retain storm water
- iv. There is a letter from the property owner to the south opposing the rezoning.
- v. Planning will make a negative declaration and is scheduled for the August 5 Planning meeting.
- vi. A community member asked if there is an affordability range for the development.
  - a. Pat Davis: The project will provide rental properties (five duplexes) for the community of Denair.
  - b. The 800 square foot property will become a single family residential for the property manager.
- vii. James Brugger moved to recommend the project for approval with the condition the parkway planter with the exiting trees is not planted in turf grass or other resource-intensive landscaping. Second by Adam Dalton. All voted in favor of recommending the project to Planning.

### B. Recommendation for <u>PLN2021-0040</u> –LAZARES COMPANIES:

- i. The project is a rezone to low-density residential and will include sixty-nine residential lots, four non-residential lots (for recreation, storm water, utilities)
- **ii.** There will be a concrete block wall on the east side of the recreation/storm basin and is planned to be covered in ivy.
  - a. James commented that the vegetation can attract pests and be maintenance and water intensive. Who is responsible for maintenance of the vegetation on the wall?
  - b. A conflict between the Denair Community Plan and the County General Plan resulted in the proposed single family residential plan.
  - c. A community member asked about consideration of gray-water systems in new developments to reduce reliance on ground water.
- **iii.** James Brugger moved to recommend deferring the recommendation until Planning can return and provide feedback/comments from Parks, Public Works and other departments. Second by Adam Dalton. All voted in favor deferring recommendation.
