Hear presentation on Staff Approval Application PLN2024-0031 – Pinnacle Partners, LLC - Request to amend the development plan of an 8.09-acre parcel in the Planned Development (P-D) 283 zoning district, which was previously approved to allow Planning Industrial uses, by allowing the construction of mini storage facilities and Recreational Vehicle (RV) storage within the existing parking lot.
