5. Monthly Reports
 - Stanislaus County Sheriff's Office: N/A as Deputy Bauman is out on family leave. October 25th SCSD will host an open house.
 - California Highway Patrol: N/A as they are short staffed, nobody was available to attend.
 - Modesto Fire Department: John Barrios reporting. Sept. 1 structure fire on Sawyer Ave., please be aware that a /control burn/ can quickly get out of control as was the case for the 9/1 fire. 14 medical calls in area last month. December 2nd Chief Kevin Wise is retiring. Though fall is upon us water rescues are still happening. East Stan Fire Safe Council will hold a cleanup in Knight's Ferry October 25th.
 - Oakdale Fire Protection District: October 9th meeting moved to October 23rd.
 - The Stanislaus County Board of Supervisors: Buck Condit reporting. We are in a new budget year (\$1.89B). There was a slight increase in property tax, but sales tax was down so the income is flat. Public Works purchased a 1-man patcher for potholes which works so well that 2 more have been ordered. One machine will primarily spend time in District 1. The county is moving \$1M for public safety from state funds- \$700K to Stanislaus Consolidated and \$300K to Oakdale. There was an issue with the SCDS
