- **B. Traffic Studies (Andrew Malizia Department of Public Works):**
 - i. McCauly & Salluce
 - 1. DPW received a few more requests for an all-way stop so it is being re-evaluated
 - 2. 4 years ago a traffic study was performed resulted in CROSS TRAFFIC DOES NOT STOP signage on 2 existing signs
 - 3. Traffic counts due next week
 - ii. Main & Lester
 - 1. DPW completed the installation of the video detection system at Main & Lester, so the signal should operate a bit better in general since some of the in-ground loops in ground were malfunctioning. DPW will be monitoring the intersection at Monte Vista to really see what's going on there and make adjustments as necessary.
 - 2. Damaged equipment upgraded
 - 3. Video detection camera (SE corner) to capture traffic flows this will help program traffic lights correctly for new flow
 - 4. Safety Study being conducted currently (identify problem behaviors using AI)
 - 5. James Brugger Crossing Lester east-bound (don't realize S bound traffic coming off of Main) is a safety issue that might be detected by study
