Denair Municipal Advisory Council Meeting Minutes Leadership Board Room 3460 Lester Road, Denair, CA November 1, 2022, 7:00 PM

I. Opening and Pledge of Allegiance

A. James Brugger called meeting to order at 7:00 PM and led the pledge to the flag.

- C. Katherine Clinkenbeard had the following comments:
 - i. How many people were aware of the <u>Stanislaus County Housing Element</u>? Did the County send out flyers?
 - **ii.** October 2021; the Denair MAC moved from an elected body to an appointed body. Why did this occur?
 - iii. Are background checks done on business owners, construction crews, or development companies before planning projects are approved?
 - iv. What would the pros and cons be of Denair becoming incorporated?
- D. James Brugger/MAC President
 - i. In approximately one decade, only one person has ever run for a MAC seat, so their name was always removed from the ballot during the election period since there was no one else running against them. If a vacancy occurs on the MAC, there is a limited amount of time (90 days) to fill the seat; if the seat is not filled during that time [when the MAC is an elected body], the seat remains open until the next election period. This poses a risk of not having enough people (a quorum is 3 MAC members) on the council to hold meetings. Moving the MAC from an elected to an appointed body removes this time restriction. See <u>Bylaws</u>
 - **ii.** MAC meetings are the best place to get information on topics that are impacting or can impact the community

A. <u>Valley Water Collaborative</u> – Jesus Nunez – <u>valleywaterc.org</u>

- i. Presenting about the Nitrate Control Program
- Public comment July 2021 Denair Community Services District notified community that the groundwater levels were decreasing; do decreasing groundwater levels impact the concentrations of nitrate? Erica stated that this presentation is related to private well, not public water provided by Denair Community Services District (DCSD); she will reach out to DCSD for an answer to that question
- iii. Higher nitrate concentrations in private well water cannot be mitigated by boiling drinking water; in fact, boiling water concentrates nitrate and results in higher levels
- iv. Private wells are being evaluated for nitrate levels
 - a. Outreach includes providing bottled water or point-of-use system, i.e., reverse osmosis





Story Time features books, stories, songs, fingerplays, rhymes, and more! It's designed for children under 5 to participate with their caregivers but all ages are welcome!



WEEKLY SCAVENGER HUNT


