 - d. Stanislaus County Public Works Department – Elliott Lea came and said they are working through a multitude of maintenance and flooding issues. They are currently experiencing a staffing shortage. The Public works department covers 1500 square miles of roads in our county.
 - e. Stanislaus County Board of Supervisors, Vito Chiesa, District 2 – Introduced the MAC to Brittany Harker as a possible replacement for Megan Wells as the Board of Supervisors Field Representative. Mr. Chiesa also offered anyone on the MAC the possibility of a ride out with the Stanislaus County Mobile Crisis Response Team.
 - f. Stanislaus County Chief Executive Office, Erica Inacio – The office is still recruiting to replace Erica's Community Relations Manager position. They are hoping to have a replacement by April or May. Erica was also going to finalize the Hickman Meeting sign for us.
6. Information Item(s) – The Stanislaus County Mobile Crisis Response Team, Horacio Madueño provided a presentation of their services. As of January 1st 2024 SMCT provides a 24 hours a day, 7 days a week, year round service to our communities. The Mobile Crisis Response Team - MCRT is here to help when you or someone you
