MINUTES

Thursday, May 1, 2025 @ 6 PM

Hickman School Auditorium

1. Chair Stephens called the meeting to order at 6:00 p.m. and led the Pledge of Allegiance
2. Roll Call (members present): Ryan Reece, Anna Rose, Nicklaus Stephens & Meredith Clark
3. Public Comment: Hickman resident Tonya Woody concerned about water quality, and if/when wells will be repaired. Wells are owned/maintained by City of Waterford, not Stanislaus County. Chair Stephens (who is also Waterford City Engineer) explained that the City of Waterford is constantly applying for grants to connect Hickman residents that don't have private wells to the City of Waterford water supply. The biggest obstacle is the State of California which does not consider it an emergency. Advised that water is tested on a weekly basis and is safe to drink. Encouraged Ms. Woody to attend the Waterford City Council meetings for updates.
4. Member Clark made a motion to approve February 6, 2025 meeting minutes. Member Rose seconded; motion passed.
5. Monthly Reports
 - a. Stanislaus County Sheriff's Office - Deputy Lauren Romero (School Resource Officer who is filling in for Deputy Bauman). There was one warrant call, one burglary, one grand theft, one vehicle collision, one attempted homicide, two information calls, and one assist to another agency. Could not find details to attempted homicide in system. Deputy Romero says there are three community service officers for the county; they are happy to come to community events.
 - b. California Highway Patrol – Not present.
 - c. Stanislaus Consolidated Fire Protection District – Not present.
 - d. Stanislaus County Public Works Department - Jason McCormick. Annual chip seal is being done on Grayson Road, no roads in Hickman. He doesn't know anything about the sidewalk project for I/4th Streets. Advised we reach out to Project Supervisor, Danny Mauricio (209-525-7564) for more info.
 - e. Stanislaus County Board of Supervisors, Vito Chiesa, District 2 – Brittany Harker, reports there was an ad hoc truck parking committee created to address illegal truck parking in District Two. They are currently gathering data and will present plan to combat issue at a later date.
