Tuesday - April 23, 2024

Nick W Blom Stanislaus County Regional Library - Salida

- 1. Meeting called to order at 7:00pm by Chair, Karen Gorne. Members present: Gorne, Schneider, Johnson. New MAC Member Donovan Torres was introduced and will be sworn in at the May meeting.
- 2. Approval of January 2024 minutes. Motion to approve/Johnson; Second/Schneider Motion Carried
- 3. Public Comment: Representative of PAL Community Sports League shared their program. Brad Johnson spoke on pesticide control and over spraying. Tami Stoller reported stop sign issue at Treetop and Finney. Horacio Madueño shared information about the mobile crisis team.

Planning Department shared information on PLN2024-0031 Pinnacle Partners, LLC. Requesting the construction of mini storage and RV parking within existing parking lot.

Action Item/s:

Planning Department shared information on PLN2023-0123 Great Valley Academy. GVA requesting to expand existing charter school with the addition of a grass athletic field, paved parking lot with 332 parking spaces and to construct 4 new classrooms.

Discussion: Walking passes issued by GVA are causing problems for nearby neighborhoods (vandalism, traffic congestion and safety concerns). After much discussion the following conditional motion was made by Chair Gorne/Seconded by board member Johnson/Motion carried As a condition of approval for PLN2023-0123 Great Valley Academy it was agreed the parties will:

- 1. Develop a student traffic plan to be circulated to the community and approved by the Salida MAC.
- 2. Limit walking passes to students who live East of Hwy 99 in Salida
- 3. A committee made up of a Salida MAC board member, Public Works, a Salida Sheriff, representatives of GVA and affected community members will meet to develop the above plan.
- 6. Council Concerns/Comments/Suggestions for Future Agenda Items
 Requested by board member Schneider to add to the June agenda a discussion about the current traffic issues on Broadway and to have a representative of Public Works attend the MAC in June.
