The agenda is divided into two sections:

- **ACTION ITEMS:** These items will be individually discussed, and an action will be taken.

In order that interested parties have an opportunity to speak, any person addressing the MAC will be limited to a maximum of 5 minutes unless the Chair of the MAC sets a different time limit.
