  - a. Stanislaus Sheriff's Department- Deputy Navarro
     May busy with 5 de Mayo festivities, present at Fairview Elementary School safety equipment event along with Fire Department.

- 26 Bills introduced of which 5 have passed onto the Senate.
- Bills 3171, 1841 and 1804 dealing with Fentanyl and Opioids are being worked on.
- f. Stanislaus County Chief Executive Office Community Relations Manager, Jennifer Hidalgo. Nothing new to share.
- g. Other Community Representative Reports Congressman Duarte, Representative Gavin Cline spoke on his behalf.
  - One of the Bills currently being worked on Bill 7525 which clarifies how district can receive federal funding.
  - Acknowledged the Behavioral Department & Stanislaus County for their involvement in helping them secure 302 million in funding to fight Fentanyl and other drug abuse. The average age of deaths is 18-45 years.

The US makes up 80% of new heroin users, 99% of hydrocodone consumers and 85% of oxycodone consumers. 2 mg (about 10-15 grains of salt) of Fentanyl consumption is all it takes to be fatal. Substance abuse helpline 1-888-376-6246. MJC West Campus will hold a 5K run on 8-31-24 to make awareness on this drug abuse.
