April 12, 2023, Meeting Minutes Valley Home School Gym 13231 Pioneer Ave, Valley Home

1. Call Meeting to Order: 6:31 PM by Chairperson Osmundson.
2. Roll Call : Members Present, W. Mullins, C. Hempleman and N. Osmundson.
3. Pledge of Allegiance to the Flag: Lead by Chairperson Osmundson
4. Public Comment:
 - Mr. Tozzi: Reported that a neighbor was concerned about local noise pollution. The location is "allegedly," on Pleasant Valley/Pioneer Roads. Options were referenced in terms of a solution and the VHMAL was asked to refer to law enforcement and county agencies for help. Ms. Lori: Asked the neighbor to turn the music down: She has missed work from the noise and has caused her health damage from the stress.

Deputy Babbit: Said: "Please see him for questions and concerns." He mentioned that the sheriff Dept. will enforce Penal Code 415- dist. the peace and it's a misdemeanor. People must call and report the complaints in order to take action from the Sheriffs Dept. It takes many calls and complaints from the people to get action. The sheriff will enforce the penal codes. The Deputy. has asked everyone not be confrontational and not to take the law in their own hands.
 - Erin Wells: Animals have been killed in the Valley Home Area, since Jan. 2023 by dogs. (One lady said that her sheep have been destroyed by the dogs).
