6.1. California Highway Patrol: **Officer Eric Moore** – Had a few calls in our area. 1 abandoned vehicle, 1 hazard, two collisions. Then there was a report of a Rooster Fight that was busted on the corner of Morse and BlueGum Ave. The academy has reopened.

6.2. Sheriff's Office: **Deputy Yom** – No arrests were made at the rooster fight. The property owner was notified of this, apparently there are renters at that property.

6.3. Salida Fire Protection District: **Pat Burns** reported that they have hired two new firefighters from the academy. That will bring them to full staffing level.

6.4. Woodland Ave. Fire Department: **no report**

6.5. Stanislaus County Board of Supervisors: **Terry Withrow** – there were only two meetings this past month. There has been a switch from COVID testing to COVID vaccinations. Really pushing to get schools back in session but it's not up to the County. The County's financial stability is in good shape. Homeless issues are back to the forefront and the emphasis is getting these people help.

6.6. Modesto Irrigation District: – **Bill Schwandt – MID General Manager** – water deliveries will be starting this Saturday. Water goes in on the 13th and deliveries to farmers begin the 17th. 36" capped allocations will be available. They will also approve Farmer to Farmer deliveries through the regular transfer program.

6.7. Hart Ransom Union School District: – no report.

6.8. Stanislaus County Public Works **Jason McCormick** reported that the County is beginning to do road surfacing work in the Wood Colony Area. Beginning in April they will begin chip seal prep and blade patching on Beckwith and then continue with other roads in our area. Currently the county only has one active truck and crew for potholing and small repairs on county roads.
