4. Approval of Minutes for MAC Meetings

6. Monthly Community Reports
 - 6.1. California Highway Patrol – Officer Moore – Nice and quiet in our area. 2 minor injury collisions and 1 accident. Huge increase in the County though, we have had one fatality on average every five days. 10% of drivers still don't wear their seatbelts. Still short on officers.
 - 6.2. Stanislaus County Sheriff's Office – no report.
 - 6.3. Salida Fire Protection District – no report.
 - 6.4. Woodland Ave Fire Department – no report.
 - 6.5. Stanislaus County Board of Supervisors or Chief Executive Office – Terry Withrow reported that there was a big cannabis bust that went on for a whole week. The county has only authorized 61 permitted grows – all indoors.
 - 6.6. Modesto Irrigation District – Stu Gilman reported that May 22 was Don Pedro's 50th anniversary. They are accepting pictures from the public. June 3rd they will be reinstating late fees, etc. for electrical customers that were suspended under COVID.
 - 6.7. Hart Ransom Union School District – Matthew Shipley reported that they just finished the school year. Five people are retiring. There are planned improvements around campus over the summer to hardscape, drainage,

concrete, electrical work, public address system and one more shade structure. Also will be adding one new school bus to the fleet.

- 7.2. David Leamon gave an update on Hwy 99 to Dakota for the Phase One Hwy 132 improvements. The project is 56.3% complete and only 1.2 million in change orders to date.
