PUBLIC COMMENT PERIOD: Matters under the jurisdiction of the MAC, and not on the posted agenda, may be addressed by the general public at the beginning of the regular agenda and any off-agenda matters before the MAC for consideration. However, California law prohibits the MAC from taking action on any matter which is not on the posted agenda unless it is determined to be an emergency by the MAC.

Any member of the public wishing to address the MAC during the "Public Comment" period shall be permitted to be heard once for up to 3 minutes unless the Chair of the MAC sets a different time limit.

The agenda is divided into two sections:

- **ACTION ITEMS:** These items will be individually discussed, and an action will be taken.

ANY MEMBER OF THE AUDIENCE DESIRING TO ADDRESS THE MAC ON A MATTER ON THE AGENDA: Please raise your hand at the time the item is announced by the MAC Chair. In order that interested parties have an opportunity to speak, any person addressing the MAC will be limited to a maximum of 3 minutes unless the Chair of the MAC sets a different time limit.

3. Roll Call: David Jones, Todd Heinrich, Lori Wolf, Lisa Braden were present, Lina Ruggirello-Danzig was absent.
4. Approval of Minutes for the August 14, 2024, Meeting as presented.
5. Public Comment- Brad and Brenden Bettencourt announced they were still working on the grand opening of Two B's Burgers at the corner of Beckwith and Finney Rds. In Modesto. They were having some trouble with obtaining the Fire Marshall's final approval. Supervisor Withrow said he would check into things for them.
6. Monthly Reports
 - a. Stanislaus County Sheriff's Office: no report
 - b. California Highway Patrol: Officer Seth Renniker reported a lot of enforcement happening on the new 132 section and also Beckwith Rd. 8-16-24 there was a non-injury crash, a pole down with minor injury, and a child fatality out west on the 132.
 - c. Salida Fire Protection District: R. Ed Bartley with Modesto Fire reported 1 structure fire, 1 vehicle fire, 9 vegetation fires, 8 accidents and 93 EMS calls.
 - d. Stanislaus County Board of Supervisors, Supervisor Withrow, District 3: Terry Withrow reported details of the newly adopted 1.8 billion dollar annual 2024-2025 budget. Only \$ 307 million is discretionary. The rest is allocated by the State of California and a lot of the money goes to schools.
 - e. Stanislaus County Chief Executive Office: No report
 - f. Modesto Irrigation District: None
 - g. Hart Ransom Union School District: Matthew Shipley thanked the County for the funding they received. He spoke about the partnership through the junior college which has the highest participation of dual enrollment in the County. They are offering a new course for calculus. This is a testimony to the quality of students that we have. Everything has to be planned a year in advance and they currently offer five different courses. This helps enormously with student loan debt because the courses are far less expensive than traditional college courses.
