Salida Fire Protection District – Ryan Winton with the Modesto Consolidated Fire District reported on the calls for the month. 143 in April and 147 in May consisting of 11 EMS, 4 CPR, and 7 Vehicle fires. He then introduced Andrew Hunter to gave us information about the new ISO rating going from a 4 to a 2 which is very important in terms of homeowner insurability.
